THE CORPORATION OF THE MUNICIPALITY OF GREENSTONE

BY-LAW 24-16

A By-law to set the rates for water services and sewer services and to set a minimum charge for water and sewer usage for 2024.

WHEREAS Section 10(1) of the *Municipal Act*, 2001, c. 25 as amended (the "Act"), grants a single-tier municipality the authority to provide any service or thing that the municipality considers necessary for the public;

AND WHEREAS Section 10(2) of the *Act* grants a single-tier municipality the authority to pass by-laws respecting services and things that the municipality is authorized to provide under subsection (1);

AND WHEREAS Section 391(1)(b) of the *Act* grants a municipality the authority to pass by-laws imposing fees or charges on any class of person for services or activities provided or done by or on behalf of it;

NOW THEREFORE the Council of the Corporation of the Municipality of Greenstone **ENACTS AS FOLLOWS**:

- 1. A water service flat rate is hereby imposed upon the owners of all lands in the Municipality of Greenstone to which water is supplied equal to \$1,158.00 per year for residential.
- 2. A sewage service flat rate is hereby imposed upon the owners of all lands in the Municipality of Greenstone to which sewer is supplied equal to \$1,063.36 per year for residential.
- 3. A water rate of \$4.18 per cubic meter will be imposed on all metered commercial and industrial users with the minimum bill being equal to a residential bill (\$289.50 per quarter.)
- 4. A sewer rate of \$3.83 per equivalent cubic meter of water will be imposed on all metered commercial and industrial users with the minimum bill being equal to a residential bill (\$265.84 per quarter.)
- 5. A water service rate is hereby imposed on all non-metered multiresidential, commercial or industrial lands in the Municipality of Greenstone to which water is supplied equal to as per Schedule "A" attached hereto.
- 6. A sewage service rate is hereby imposed on all non-metered multiresidential, commercial or industrial lands in the Municipality of Greenstone to which sewer is supplied equal to as per Schedule "A" attached hereto.
- 7. A penalty charge in accordance with the Municipality of Greenstone "Collection Water and Sewer" Policy shall be imposed on all bills not paid by the specified due date.
- 8. Water bill accounts that are in arrears and requests for Meter Testing will be handled as per the Water and Sewer Billing Collection Policy (Resolution 17-84).
- 9. If no payment is received, or acceptable payment arrangements have not been made with the Corporate Services Department, the water supply to the property shall be turned off.

- 10. Copies of all water disconnection notices are sent to the Public Works Working Supervisors of each applicable Ward.
- 11. This By-law shall come into force upon enactment and the rates herein set out in Schedule A as attached hereto and forming part of this by-law shall be effective March 1, 2024 for all property owners in the Municipality of Greenstone.
