

THE CORPORATION OF THE MUNICIPALITY OF GREENSTONE

BY-LAW 21-42

Being a By-law to adopt the estimates of all sums required during the year 2021 (Operating and Capital related to Seniors)

WHEREAS Section 290 of the *Municipal Act, 2001, c.25*, as amended (*the "Act"*) prescribes that the Municipality of Greenstone shall prepare and adopt a budget including estimates of all sums required during the year for the purposes of the municipality;

AND WHEREAS revenues and expenses for seniors programs have been removed from the general estimates for operating and capital amounts as provided in By-law 21-XX


AND WHEREAS the revenues and expenses for senior related operating programs and amounts for seniors related capital projects are separately provided below, and the tax levy is reduced by the equivalent operating expenses for seniors programs and that portion provided below;


NOW THEREFORE THE CORPORATION OF THE MUNICIPALITY OF GREENSTONE ENACTS AS FOLLOWS:

1. THAT Council approve for Seniors related programs for 2021, operating revenues of \$197,588 and operating expenses of \$276,821 for a net budget expense amount of \$79,263, which has been removed from the general estimates;
2. AND THAT Council approve a seniors related tax levy amount for 2021 of \$79,263, which has not been included in the general estimates tax levy;
3. AND THAT Council approve seniors related capital expenditures for 2021 of \$210,406, which is in addition to the capital included in the general estimates.
4. This By-Law shall come into force and take effect on the date of its passing.
