

THE CORPORATION OF THE MUNICIPALITY OF GREENSTONE

BY-LAW 23-15

Being a By-law to establish General Fees and Charges and Conditions for the Corporation of the Municipality of Greenstone (2023)

WHEREAS Section 385 of the *Municipal Act*, 2001, c.25 as amended (the “*Act*”) provides that a municipality may fix a scale of costs to be charged as reasonable costs of proceeding under Part XI of said *Act*;

AND WHEREAS Section 391 of the *Act* provides that a municipality may pass by-laws imposing fees or charges on persons for services or activities provided or done by or on behalf of it; for costs payable by it for services or activities provided or done by or on behalf of any other municipality or local board; and for the use of its property including property under its control;

AND WHEREAS the *Planning Act*, R.S.O. 1990, c. P.13, as amended, Section 69 authorizes the establishment of a tariff of fees for the processing of applications made in respect of planning matters, which tariff shall be designed to meet only the anticipated cost to the municipality or committee;

AND WHEREAS the Council of the Municipality of Greenstone deems it necessary and expedient to pass a by-law to establish general fees and charges for the Municipality of Greenstone;

NOW THEREFORE THE CORPORATION OF THE MUNICIPALITY OF GREENSTONE ENACTS AS FOLLOWS:

1. **THAT** the following schedules attached hereto and forming part of this By-law setting out the various departmental fees and charges and conditions are hereby approved:

- Schedule A – General, Community Centres and Pool
- Schedule B – Daycare Centres
- Schedule C – Transit
- Schedule D – Public Works
- Schedule E – Public Works Equipment
- Schedule F – Airport
- Schedule G – High Hill Harbour
- Schedule H – Campgrounds
- Schedule I – Planning
- Schedule J – Property Standards
- Schedule K – Licensing
- Schedule L – Animal Control
- Schedule M – Fire Services
- Schedule N – Cemetery

2. **THAT** the fees, charges, and conditions set out on the attached Schedules shall be subject to the applicable taxes.
3. **THAT** the fees become due and payable upon the terms and conditions of any executed Agreements between the Municipality and the person.
4. **THAT** the fees and charges in this by-law shall supersede all previous by-laws, motions, or policies related to the departments contained in this by-law, from the Municipality of Greenstone, former Town of Geraldton, former

Town of Longlac, former Township of Beardmore or former Township of Nakina.

5. **THAT** this By-law shall come into force and take effect immediately on the passing thereof.
