

## 2022 MUNICIPAL AND SCHOOL BOARD ELECTION COMPLIANCE REPORT

This compliance report is in accordance with Section 88.23(4-5) of the *Municipal Elections Act*, 1996 (MEA). The MEA requires the Clerk to make available to the public a report setting out all candidates in an election and indicating whether each candidate complied with Section 88.25 and Section 88.34 (1) of the MEA.

Section 88.25 of the MEA requires each candidate that filed their nomination papers with the Clerk, to file financial statements on or before 2:00 p.m. on Friday March 31, 2023.

In accordance with Section 88.34(1) the Clerk shall review the contributions reported on the financial statements submitted by a candidate under section 88.25 to determine whether any contributor appears to have exceeded any of the contribution limits under Section 88.9 of the MEA.
