



## POPLAR LODGE PARK SEASONAL LOTTERY SYSTEM

### Conditions of Application and Site Selection

#### Eligibility and Application

Only one application per family is permitted. Family is generally defined as parent(s) and children under 18 years of age.

**NOTE: Submitting multiple applications under different names, applying for someone else, or completing an application for occupants other than yourself will result in forfeiture of the campsite and fees, and disqualification from next season's draw.**

Approximately 50% of our electrical sites will be awarded (23 sites) and 15% of our non-electrical sites will be awarded (3 sites) during the seasonal draw.

Applying for the seasonal site lottery does not guarantee a seasonal site at Poplar Lodge Park (PLP). Site selection is based on draw order, and successful applicants must pay in full within 24 hours of being contacted by a municipal employee.

A \$100.00 non-refundable credit card deposit to the Municipality of Greenstone is required with the application by the deadline. Incomplete applications or those without payment will not be accepted.

It is your responsibility to ensure that your payment is received by the deadline to be included in the draw.

All applications must be submitted no later than 3:00 p.m. EST on Friday, May 1, 2026. Applications may be submitted by email to [denise.cote@greenstone.ca](mailto:denise.cote@greenstone.ca), by mail, or in person at the Beardmore Ward Office.





## Seasonal Draw Process

The 2026 seasonal campsite draw at Poplar Lodge Park will be held at the Beardmore Ward Office on Monday, May 4, 2026.

The draw will be conducted by a municipal employee and witnessed by two additional municipal employees. Applicants are not permitted to be in attendance. Site selection will follow the order names are drawn.

Successful applicants will be notified by phone starting Monday, May 4, 2026, in the draw order to choose a site. Please have your campsite preferences ready to avoid delays.

Unsuccessful applicants will have the option of a monthly site.

## Monthly Site Process

Monthly sites will begin on the opening day and run for 31 days. Full payment is required before occupying your site.

There is no guarantee that you will be awarded a monthly site.

Electrical Sites	Monthly - \$800.06 + \$104.01 (HST) = \$904.07
Non-Electrical Sites	Monthly - \$668.73 + \$86.93 (HST) = \$755.66

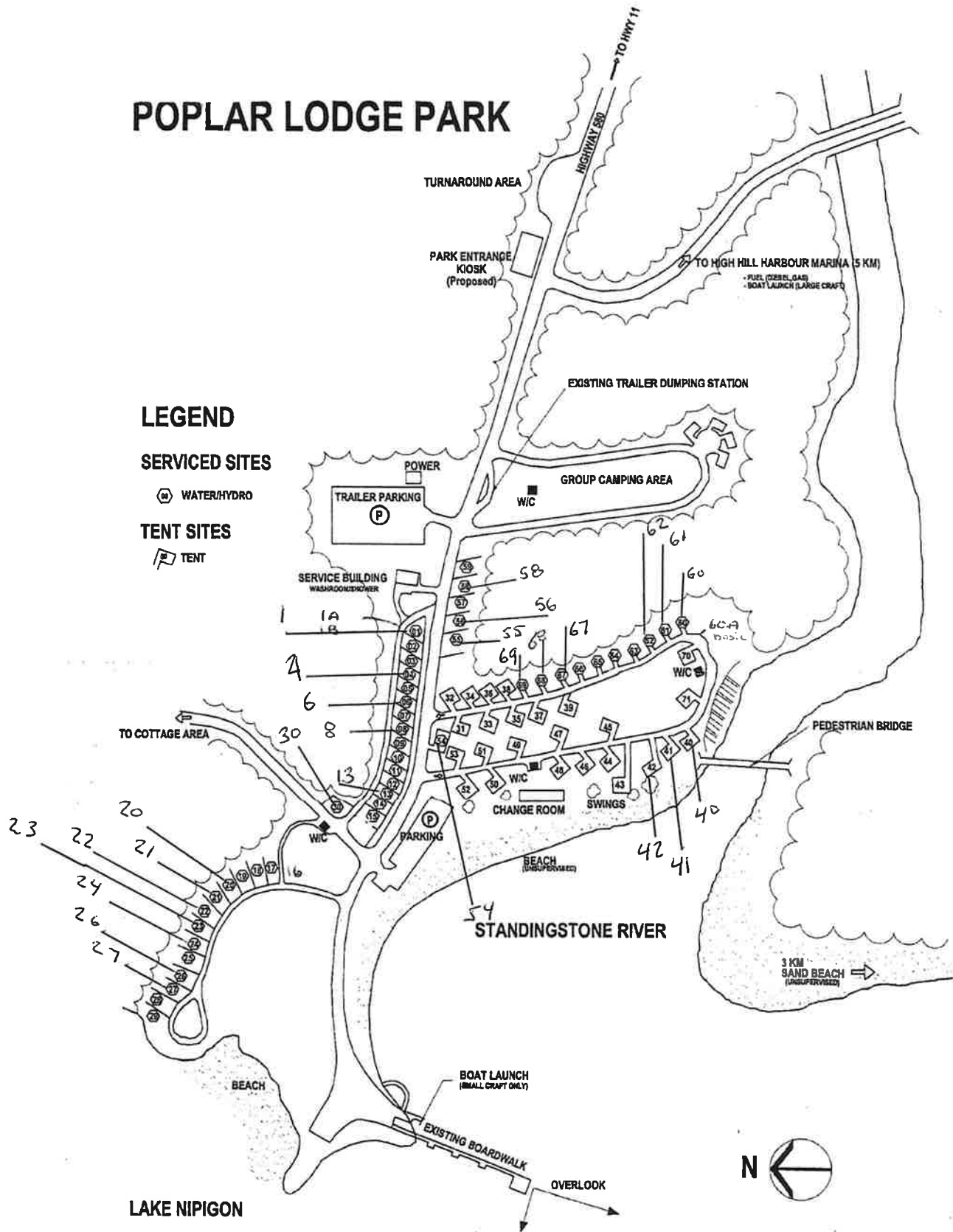
